Lawrence Township Public Schools Safe Return to In-Person Instruction Plan

Date: June 20, 2021

Date Revised: December 8, 2023

During the 2023-2024 school year, all students are required to attend in-person learning. This will take place five (5) days/week (when schedule permits). We continue to follow guidance from the NJDOE, the CDC, and our local health department.

LTPS will continue to implement the following COVID-19 prevention and control strategies, as recommended by NJ Department of Health.

- Encourage students and staff to stay up to date with vaccination.
- Encourage students and staff to stay home when sick.
- Maintain school policies for reporting positive test results and illness.
- Enforce exclusion for those who are symptomatic or have tested positive for COVID-19 and other illnesses.
- Provide information to parents, students, and staff on prevention strategies including testing and masking following illness and exposure.
- Support mask use by students and staff who choose to mask at any time.
- Implement control measures recommended by LHDs in response to clusters of cases (including increases in respiratory illness) and confirmed outbreaks.
- Continue to report outbreaks and suspected outbreaks immediately to LHDs.
- Follow NJDOH reporting requirements for reportable diseases.

Outbreaks or newly circulating variants of concern may necessitate more stringent disease control strategies

Maintaining Health and Safety

A. Ensure correct wearing of masks, when needed

As of the date of this plan, all Lawrence Township Public School (LTPS) students, staff and visitors are invited to wear masks while in the school buildings if it fits their personal beliefs. By using the state guidelines if someone tested positive and has been quarantined for five days they are required to wear a mask in our schools for the next five days assuming they are symptom free. Should we receive any additional information from the New Jersey Government, the New Jersey Department of Education or our local health department, that would suggest we should change our current mask rules, we would communicate at that time with our school community.

A. Physical distancing (i.e., including use of cohorts/podding)

We will continue to follow any guidance of the NJDOE and our local health department.

B. Reinforce Handwashing and Respiratory Etiquette

Teach and reinforce handwashing with soap and water for at least 20 seconds and increase monitoring of students and staff.

If soap and water are not readily available, hand sanitizer that contains at least 60% alcohol can be used (for staff and older children who can safely use hand sanitizer).

Encourage students and staff to cover coughs and sneezes with a tissue if not wearing a mask.

Used tissues should be thrown in the trash and hand hygiene as outlined above should be performed immediately.

Have adequate supplies including soap, hand sanitizer with at least 60% alcohol (for staff and older children who can safely use hand sanitizer), paper towels, tissues, and no-touch trash cans.

C. Cleaning and maintaining healthy facilities and ventilation

LTPS will adhere to existing required facilities cleaning practices and procedures, and any new specific requirements of the local health department as they arise. LTPS will also continue its schedule for increased routine cleaning and disinfecting, especially of frequently touched surfaces and objects, and sanitize bathrooms daily and periodically throughout the day.

LTPS has established a COVID-19 Cleaning Protocol that specifically identifies commonly touched and infrequently touched surfaces. The protocol calls for frequent cleaning and disinfection using select methods and products that are balanced based on need. Need includes how quickly an area may need to be disinfected and how safe the product is to use. For example, frequently touched surfaces may require the use of a product that kills the Covid virus after allowing the product to "dwell" on the surface for 30 seconds. Other areas may be

cleaned and disinfected using a product that is more "green" and has a 5 minute dwell time. The choice of the product and method varies within the Cleaning Plan based on need.

Indoor Air Quality

HVAC units will be continuously inspected to ensure that proper air exchange is occurring. Filter change logs will be maintained for all HVAC units. HVAC units will be visually inspected to ensure proper air damper and fan functioning.

When air conditioners are running AND where the proper amount of fresh air is being introduced (in accordance with manufacturer's recommendation) occupants should not open windows. When air conditioners are NOT running, occupants are encouraged to open windows to increase air circulation provided that occupants are free of allergy and other health concerns.

Each classroom and office space has also been provided with stand alone HEPA Filtration machines.

D. Contact tracing in collaboration with the State or local health department guidelines, if needed

Contact Tracing

Contact tracing is the process to identify those who come in contact with people who have tested positive for a contagious disease. It is used to inform, provide guidance, and offer support to individuals. Contact tracing is a long-standing practice in NJ and around the world to control the spread of disease.

All of the district nurses have been trained using the State of NJ contact tracing program. If you develop symptoms of COVID-19 or test positive, the district nurses will work in conjunction with Lawrence Township Health Department, to identify and notify your close contacts.

Close contact is defined as being within 6 feet of someone with suspected or known COVID-19 for 15 or more minutes during a 24-hour period. In certain situations, it may be difficult to determine whether individuals have met this criterion and an entire cohort, classroom, or other group may need to be considered exposed. Prompt notification to students and families regarding exposure to infectious diseases, including COVID-19, can allow for rapid testing, early treatment, and prevention of further spread. No names or personal information shall be shared.

"Quarantine" Definition

Quarantine keeps someone who was in close contact with someone who has COVID-19 away from others.

Quarantine is no longer recommended for people who are exposed to COVID-19 except in certain highrisk congregate settings. In schools and ECE settings, which are generally not considered high-risk congregate settings, people who were exposed to COVID-19 can continue to attend school as long as they remain asymptomatic. CDC recommends that individuals who were exposed to COVID-19 wear a well-fitting mask for 10 days after exposure.

"Isolation" Definition

Isolation keeps someone who is sick or asymptomatic but tested positive for COVID-19 away from others, even in their own home.

E. Diagnostic and screening testing

Stay Home when sick

Staff, students, and their families should stay home and when they should return to school. We will provide clear and accessible directions to parents/caregivers and students for reporting symptoms and reasons for absences and strictly enforce exclusion criteria for both students and staff.

Parents/caregivers should be strongly encouraged to monitor their children for signs and symptoms of illness every day and keep them home if they:

- Have tested positive (viral test) for COVID-19.
- Have symptoms of respiratory or gastrointestinal infections (e.g., cough, fever, sore throat, vomiting, diarrhea)

Daily Symptom Monitoring

Families receive and sign off on the district parameters surrounding the Daily Symptom expectations prior to participating in the district's summer program. This will make the families aware of what they should do each day before sending their child to school. The acknowledgment will also inform them about what to do should their child have any of the disqualifying symptoms.

Students Who Experience Symptoms at School

- Students who are feeling ill at school should immediately report to the school nurse's office.
- Students who are determined by the school nurse to be displaying possible COVID-19 symptoms will wait in the isolation room until a parent or guardian can come to pick them up.
- It is expected that every family has a plan in place to be able to pick up your ill child within 1 hour of being notified by the school nurse.
- For the health and safety of all staff and students, every student living in the same household are considered close contacts and therefore must be picked up as well.

This information continues to be shared with families through the regular school communications such as newsletters, back to school nights, etc.

F. Efforts to provide vaccinations to educators, other staff, and eligible students

Since February of 2021, the district has shared information about vaccination sites and information that the district received from the county health department and the state. The information provided allowed staff to sign up on their own to enroll in the state system to pre-register or register for the COVID-19 vaccine.

Subsequently, the district has held two vaccination clinics and partnered with surrounding districts that enabled the staff to attend other vaccination clinics in the surrounding area.

The district held a vaccination clinic for staff that administered over 100 vaccinations with the first date on April 5, 2021 and the second on May 4, 2021.

The district held a vaccination clinic for eligible students aged 12 and above and administered over 240 vaccinations with the first date on June 4, 2021 and Penlar Pharmacy in Lawrenceville.

The district will host additional vaccination clinics as needed.

Special Education

Specific strategies and considerations for students with disabilities must be critical points of discussion for every return-to-school scenario.

Ensuring Continuity of Services

The district curriculum has been revised to reinforce the essential skills from the previous school year. The district will continue to reinforce the necessary skills to make sure the students have the foundational knowledge to be successful in the immediate and in the future.

The district is providing a variety of after school programs to support the instructional needs of students in K - 12. Contact your building main office for more information.

LTPS has contracted w/ mental health professionals to provide consultations directly with students. The counseling will support their social / emotional and overall mental wellbeing.

In accordance with guidance from the NJDOE, should a student need to quarantine because they have contracted COVID-19 or if it has been verified by the school nurse that they have been a close contact, they will be permitted to participate in a live stream of the daily instruction. If necessary, these students will be loaned a device.

Fully Remote (If necessary)

Should a class, a school or the district have the need to go fully remote, the impacted students will obtain their instruction virtually via Zoom. Unless told otherwise, students will follow their regular schedule and obtain the instruction by the links provided from the teacher(s). Each teacher will provide a link to their Zoom session and students can find the coursework in the teachers Google Classroom.

Public Comment

We shared our plan at our Board of Education meeting on August 25, 2021. We had three (3) opportunities for public comment following the presentation.

In addition each school held a Town Hall meeting in June to gather feedback from the previous year. The district used this feedback when revising the previous plan.

LTPS utilized the template for our reopening plan and met with constituents to provide a narrative to the required information.

The information will be posted on the district website. Our website is able to be translated into the various languages that are spoken in our community. The website also translates "word" documents into speech to text. These features allow our families to obtain the information in a language that is appropriate for their needs.

3. Briefly describe any guidance professional learning and technical assistance opportunities the LEA will make available to its schools.

The district has provided a number of consultants and professional learning opportunities. These opportunities have focused on mental health, instructional strategies, equity and diversity and teaching within an extended learning period. All classrooms have been outfitted with a Zoom bar and a television to streamline the opportunities to live stream into their classroom. Staff has also been provided with training and guidance on using this equipment.

Should Mercer County go into the "Low Risk" phase, it is expected that schools will be able to reduce the current social distancing parameters.

As of this time, the guidance requires 3 feet for social distancing when eating. Should this guidance be adjusted, we will adjust our district guidelines accordingly.

The six steps to follow for proper hand washing

1. Wet hands with warm water.

- 2. Use enough soap to produce lather.
- 3. Rub hands together for 15-20 seconds.
- 4. Wash hands thoroughly under running water to remove the soap.
- 5. Pat hands dry with a paper towel.
- 6. Use a towel to turn off the tap.

A close contact is when a person is within 6 ft. of an infected person for a cumulative total of 15 minutes or more over a 24 hr. period starting from 2 days before illness onset (or for asymptomatic people, 2 days prior to Covid test) until the time the person is isolated)

Contact tracers provide information to close contacts about the risk of developing illness, daily symptom monitoring, how to prevent the spread of virus, and where they can get tested.

Confidentiality is Key! No names or personal information is shared.

Need includes how quickly an area may need to be disinfected and how safe the product is to use. For example, frequently touched surfaces may require the use of a product that kills the Covid virus after allowing the product to "dwell" on the surface for 30 seconds. For example, frequently touched surfaces may require the use of a product that kills the Covid virus after allowing the product to "dwell" on the surface for 30 seconds. Other areas may be cleaned and disinfected using a product that is more "green" and has a 5 minute dwell time. The choice of the product and method varies within the Cleaning Plan based on need.

Indoor Air Quality

HVAC units will be continuously inspected to ensure that proper air exchange is occurring. Filter change logs will be maintained for all HVAC units. HVAC units will be visually inspected to ensure proper air damper and fan functioning.

When air conditioners are running AND where the proper amount of fresh air is being introduced (in accordance with manufacturer's recommendation) occupants should not open windows. When air conditioners are NOT running, occupants are encouraged to open windows to increase air circulation provided that occupants are free of allergy and other health concerns.

Each classroom and office space has also been provided with stand alone HEPA Filtration machines.

13. Contact tracing in combination with isolation and quarantine, in collaboration with the State, local health department

Contact Tracing

Contact tracing is the process to identify those who come in contact with people who have tested positive for a contagious disease. It is used to inform, provide guidance, and offer support to individuals. Contact tracing is a long-standing practice in NJ and around the world to control the spread of disease.

If you test positive for COVID-19, you may have already transmitted the virus to others. Those individuals could now be infected and spreading the virus to others.

Contact tracing is critical to stopping the spread of COVID-19 and keeping you, your family, your friends, and your community safe and healthy.

All of the district nurses have been trained using the State of NJ contact tracing program. If you develop symptoms of COVID-19 or test positive, the district nurses will work in conjunction with Lawrence Township Health Department, to identify and notify your close contacts.

A close contact is when a person is within 6 ft. of an infected person for a cumulative total of 15 minutes or more over a 24 hr. period starting from 2 days before illness onset (or for asymptomatic people, 2 days prior to Covid test) until the time the person is isolated)

Contact tracers provide information to close contacts about the risk of developing illness, daily symptom monitoring, how to prevent the spread of virus, and where they can get tested. Confidentiality is Key! No names or personal information is shared.

Quarantine vs. Isolation

Quarantine keeps someone who was in close contact with someone who has COVID-19 away from others.

Isolation

Isolation keeps someone who is sick or asymptomatic but tested positive for COVID-19 away from others, even in their own home.

14. Diagnostic and screening testing

Daily Symptom Monitoring

Families receive and sign off on the district parameters surrounding the Daily Symptom expectations prior to participating in the district's summer program. This will make the families aware about what they should do each day before sending their child to school. The acknowledgement will also inform them about what to do should their child have any of the disqualifying symptoms.

Student Daily Symptom Tracker

Reminders:

- Take your child's temperature (A fever is 100 degrees F or higher)
- Check your child for symptoms
- Complete Qualtrics Student Daily Symptom Tracker in your email before 7:00am.
- Make sure your child is wearing a mask (pack an extra mask for safety)

Students Who Experience Symptoms at School

- Students who are feeling ill at school should immediately report to the school nurse's office.
- Students who are determined by the school nurse to be displaying possible COVID-19 symptoms will wait in the isolation room until a parent or guardian can come to pick them up.
- It is expected that every family has a plan in place to be able to pick up your ill child within 1 hour of being notified by the school nurse.
- For the health and safety of all staff and students, every student living in the same household are considered close contacts and therefore must be picked up as well.
- 15. Efforts to provide vaccinations to educators, other staff, and eligible students

Since February of 2021, the district has shared information about vaccination sites and information that the district received from the county health department and the state. The information provided allowed staff to sign up on their own to enroll in the state system to pre-register or register for the COVID-19 vaccine.

Subsequently, the district has held two vaccination clinics and partnered with surrounding districts that enabled the staff to attend other vaccination clinics in the surrounding area.

The district held a vaccination clinic for staff that administered over 100 vaccinations with the first date on April 5, 2021 and the second on May 4, 2021.

The district held a vaccination clinic for eligible students aged 12 and above and administered over 240 vaccinations with the first date on June 4, 2021 and the second will take place at the Penlar Pharmacy in Lawrenceville.

Special Education

Every child and adolescent with a disability is entitled to a free and appropriate education and is entitled to special education services based on their individualized education program (IEP). Since the onset of virtual instruction, the NJDOE has engaged a variety of stakeholders, including educators, related service providers and advocacy groups to gain insight, share best practices, and consider policies to support districts in providing services to students with disabilities in virtual or hybrid learning Environments.

Consistent with guidance from the United States Department of Education, districts must continue to meet their obligations to students with disabilities to the greatest extent possible. The NJDOE will continue to update school districts and receiving schools with any additional guidance from the USDE on implementation of IDEA. Specific strategies and considerations for students with disabilities must be critical points of discussion for every return-to-school scenario. To support our students with disabilities for the 21-22 school year.

LTPS will work w/ a consultant to address specific learning needs. The consultants will support students during the summer of 2021 and the 2021-2022 school year to provide additional opportunities to support the student's instructional needs.

LTPS has contracted w/ mental health professionals to provide consultations directly with students. The counseling will support their social / emotional and overall mental wellbeing.

The district curriculum has been revised to reinforce the essential skills from the previous school year. The district will continue to reinforce the necessary skills to make sure the students have the foundational knowledge to be successful in the immediate and in the future.
